5 Fire Fighting Measures

Suitable Extinguishing Media: Water fog or fine spray.

Specific Hazards Arising from the Chemical:

Hazardous combustion products include oxides of carbon and other unidentified potentially hazardous fumes. Product is not flammable.

Personal Precautions, Protective Equipment and Emergency Procedures:

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and sweep powder into a pile and transfer into suitable containers for subsequent disposal. Avoid generating dust. Provide adequate ventilation. Decontaminate spill area with detergent and water.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye contact and inhalation of dust.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.
