6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear Safe Work Australia approved protective clothing. Evacuate all non-essential personnel from affected area. Do not breathe vapours. Ensure adequate ventilation.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and absorb spill with s and, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal.

7. HANDLING AND STORAGE

Precautions for Safe Handling:
